Mehedi Hasan, Director (Business Development), ELECTROPATHY ELECTRONICS, 31, Mohakhali C/A, Bir Uttam A K Khandakar Road, Tejgaon, Dhaka.** (hereinafter called “the Supplier”) of the other part:

WHEREAS the PE invited Tenders for certain goods and related services, viz, “*Supply, Installation and commissioning of CCTV System, Display Monitor and Multimedia Projector*” and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of *Tk. 2242688.999 (Taka TWENTY-TWO LAKH FORTY-TWO THOUSAND SIX HUNDRED AND EIGHTY-EIGHT POINT NINE NINE NINE)* (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.

 - (f) Technical Specifications;
 - (g) Drawings;
 - (h) Price Schedules and Schedule of Requirements and;
 - (i) other document including correspondences listed in the PCC forming part of the Contract
3. In consideration of the payments to be made by the PE to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the PE to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The PE hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




